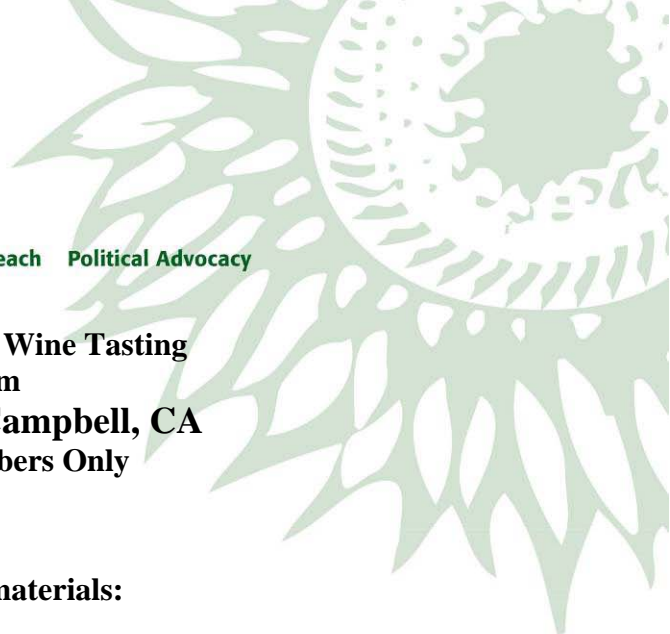

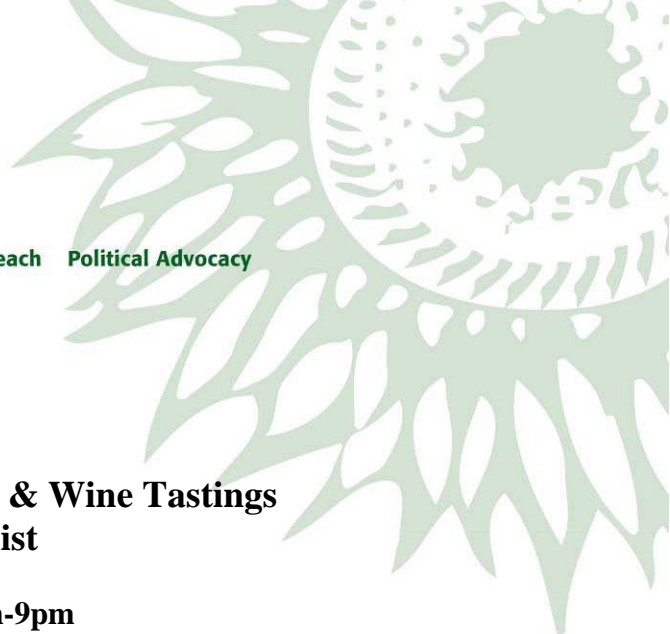

**Deposit for Participation**

Your participation will be confirmed upon receipt of your \$200 deposit, which will be returned to you in full after the event. If you are unable to attend and inform us at least 30 days before the event you will receive 50% of your deposit. If you do not show up to the event, or if you arrive more than 30 minutes late, you will forfeit the entire deposit.

**Certificate of Insurance**

Please note that we require from you a certificate of liability insurance stating that CCOF is covered under your insurance policy for the day of the event for both your general and liquor liability. Please note that you can simplify this process and avoid any future administrative fees by having your insurance provider add CCOF to your annual policy.

**Pour Spouts**

Wineries must bring 2oz. pour spouts for their product to ensure consistent pour sizes at the event.

**Case Volume for Pouring**

Please bring a minimum of 4 cases of your product to be poured at each of this year's events, to ensure that you will not run out before the end of the event.

**Silent Auction Donation**

The minimum value for your silent auction donation is \$100.
