- ▶ For each animal include the following:
 - 1) Animal Identification information and birth date.
 - 2) Organic status of the animal: Animals that have been transitioned or treated with a prohibited parasiticide may be eligible for organic status but are not eligible as organic slaughter stock. Only animals that have been managed organically from their last third of gestation and not treated with any synthetic dewormers are eligible for sale as organic slaughter stock.
 - 3) OPT Grass-Fed or other livestock program status, if applicable.
 - 4) Source of the animal: If the animal was born on your operation, list the Dam's identification information. If the animal was purchased, list the name of the certified seller as well as the previous animal ID if it was changed upon purchase. This information should correspond with animal purchase records.
 - 5) If the animal is not eligible for sale as organic slaughter stock, indicate the reason in the applicable column. List the specific parasiticide administered if applicable.
 - 6) Comments may include information regarding visual identification such as colored ear tags or notched ear tags, or other notes you wish to capture.
 - 7) Reason an animal was removed from the farm, as well as the date removed. This information should correspond with medical records, cull records, and/or sales records.
