



OCal Labeling Guide





This guide describes labeling requirements for OCal cannabis products (nonmanufactured and manufactured). All labels applied by CCOF-certified operations must be pre-approved by CCOF prior to printing.

- ▶ **Nonmanufactured cannabis products:** flower, shake, leaf, pre-rolls, and kief that is obtained from accumulation in containers or sifted from loose, dry cannabis flower or leaf with a mesh screen or sieve [3 CCR 10000].
- ▶ **Manufactured cannabis products:** cannabis that has undergone a process whereby the plant material has been transformed into a concentrate. This includes, but is not limited to, concentrated cannabis, an edible or topical product containing cannabis, or concentrated cannabis containing other ingredients [17 CCR 22000]. Cannabis extracts must only be extracted using water, steam, ice, dry ice, organic butter, organic oil, organic ethanol, carbon dioxide, or mechanical methods [17 CCR 22035(c)].
- ▶ Products may be subject to additional cannabis labeling requirements pursuant to Division 10 of the Business and Professions Code and its implementing regulations. This guide is for reference only and does not supersede any local, state or Federal regulations.

Ingredient Statement	<ul style="list-style-type: none"> Must identify each OCal cannabis ingredient with the word "OCal" or with an asterisk or other mark that is defined below the ingredient statement to indicate the ingredient has been OCal produced. Must identify each organic ingredient with the word "organic" or with an asterisk or other mark that is defined below the ingredient statement to indicate the ingredient has been organically produced. 	<p>17 CCR 22055(d), 22055(e)</p> <p>3 CCR 10300</p>
Certifier Identification	Required on all OCal retail product labels. The information panel must include "Certified OCal by (CCOF name and/or logo)" directly below the information identifying the cultivator or handler of the product.	<p>17 CCR 22055(f)</p> <p>3 CCR 10300</p>
The term "Organic"	<p>Cannabis operations are prohibited from selling, labeling, or referring to their products as organic. The term "organic" must not be used on any product label or advertising material to describe the product or modify the product name.</p> <p>The term "organic" can only be used to identify organic ingredients in the ingredient statement.</p>	<p>17 CCR 22055(e), 22055(g), 22055(h)</p> <p>3 CCR 10103</p>
OCal Seal	<p>The OCal seal may only be used on nonmanufactured products and manufactured products labeled "OCal" or "100% OCal". The OCal seal may not be used on products labeled "Made with OCal Cannabis".</p> <p>Use of the OCal seal is optional and must be used in the specific format and colors as defined by the OCal regulations:</p> <ol style="list-style-type: none"> On a white background and with the term "OCal" ("O" in green with white cannabis flower inside "O" and "Cal" in orange overlapping the "O"). On a white or transparent background with the term "OCal" ("O" in dark gray with white cannabis flower inside "O" and "Cal" in black overlapping the "O"). <div style="display: flex; justify-content: space-around; align-items: center;">   </div>	<p>17 CCR 22055, 22065</p> <p>3 CCR 10300, 10302</p>

Nonmanufactured nonretail cannabis	Nonretail containers used to store or transport nonmanufactured OCal cannabis products must display obviously visible OCal identifiers on the outside of the container.	3 CCR 10301
Manufactured nonretail cannabis	<p>Nonretail/ bulk containers used to store or transport manufactured OCal cannabis products must display:</p> <ul style="list-style-type: none"> Identifying information that the product is "OCal" on the outside of the container. Batch or lot numbers to provide traceability. 	17 CCR 22060
